**Permission to Trespass Licence for a POSOL Residential berth
(Overhang into adjacent berth)**

This form may be used where a boat is wider than the berth on which it is desired to moor and where the owner of the adjoining berth is willing to grant a licence for the boat to trespass into his or her berth. The width of a boat here is to include fendering and riding scope appropriate for the size of the boat. Where the neighbouring owner is not willing to license the trespass, POSOL cannot register the boat and it will not be permitted to moor on the desired berth.

WHEREBY IT IS AGREED

Grant of Licence

1. The licensor grants permission to the licensee for THE BOAT to trespass into part of the licensor's berth.
2. This licence shall continue until either party terminates it by giving 3 months written notice of termination to the other. Such notice may be given without giving a reason.
3. The licensee, on being given notice, must remove THE BOAT from the licensee's berth by the termination date.
4. The licence will automatically terminate if the licensee replaces THE BOAT for another, or if the berth it occupies is sold.
5. A copy of this licence must be lodged with POSOL's Managing Agent, before the overwidth boat can be registered and approved to moor on the desired berth.
6. A copy of any termination notice shall also be lodged with POSOL's Managing Agent.
